

TO ALL CHRISTIAN PEOPLE TO WHOME THIS PRESENT WRITEING SHALL COME, SIRHAM, INDIAN, SACHEM OF SACHUS, PANNSKAPHAM, CHARRISH, USHEWAEN, PEWENEMIN, SICKHAM, trew and lawfull owners and Indian Proprietors of the land herein mentioned. SEND GREETEING KNOW YEE, that for and in consideration of a certaine quantety of Wampum and divers other goods in a schedull hereunto annexed perticularly mentioned and expressed to them the said Indians in hand paid by Tevnis Dekey, Richd. Abramson, Jacob Abramson, Sibout Harche, Jacob Harche, and Samuell Dekey, all of the City of New Yorke, the receipt whereof they the said Indians doe hereby acknowledge and therewith owne themselves to be fully payd contentted and sattisfied and thereof, and of every part and parcell doe hereby acknowledge to have acquitted exhonerated and discharged them

the said Tevnis Dekey, Richard Abramson, Jacob Abramson, Siboute Harche, Jacob Harche and Samuell Dekey their heires, and assignes have given granted, bargained, sold, aliened, enfeoffed and confirmed and by these presents doe fully clearely absolutely give grant, bargaine, sell, alien, enfeoffe and confirme unto the said Tevnis Dekey, Richard Abramson, Jacob Abramson, Siboute Harchie, Jacob Harche, and Samuell Dekey all that tract or parcell of land scittuate lyeing and being on Hudsons River at a certaine place called by the Indians Sachus, and Stretching by the north side of Me. Stevannus Courtland land up to the said River to a norther creeke and so runs up said creeke in severall courses to a certaine tree, marked with TR and from the said marked tree southerly by marked trees all alonge to a marsh to another marked tree marked TR west up to the aforesaid creeke which lyes by the said Me. Stevannus Courtlands land and including all the meadow both fresh and salt within the said bounds.

TOGAITHER with all the lands soyles, meadows pastures, commons woods, lands marshes rivers, rivoletts streams creekes, waters, lakes, and whatsoever else, to the said tract of land within the bounds and limmitts aforesaid belonging or in any wise appertaineing without any reservation of herbage trees or any other thinge growing or being thereupon. TO HAVE AND TO HOLD the said tract or parcell of land meadow ground and premisses with there and every of there appurtenances unto the said Teunis De Key, Richard Abramson, Jacob Abramson, Sibout Harche, Jacob Harche and Samuell Dekey their heires, and assigns to the only use and behoofe of them the said Tevnis Dekey, Richard Abramson, Jacob Abramson, Sibout Harche, Jacob Harche and Samuell Dekey, their heires, and assigns forever. AND WEE the said Indians aforesaid owners of the abovesaid and the said bargained land and premisses with every of there appurtenances against us and our heires, forever, shall and will warrant and forever by these presents defend. IN TESTEMONY WHEREOF wee the within named Indians unto these presents have hereunto sett our hands and seales in N. Yorke the 21th day of Aprill in the 37th yeare of his Matis. Reigne Anno. Domi. 1685.
